In addition, the Authority reserves the right, should the circumstances merit it, to extend each of the contracts for another period of up to 24 months giving potential total contract term for each of the contracts of 84 months.

The value of each Call-off Contract is the estimated value if all of the contract extensions are fully utilised.

The total value of all 4 Call-off Contracts has been included in II.1.7.

The estimated total value includes an estimated amount for inflation and is based on estimated tonnages, however, the actual total value spent under the Call-off Contracts may change due to volumes of Contract Waste and variations in the actual levels of inflation from what has been estimated.
