This framework will provide councils and other participating bodies with a mechanism to procure a wide range of heavy and municipal vehicles, covering the varied fleet mix across councils. This will incorporate various vehicle types, such as, but not limited to, refuse collection vehicles, winter maintenance vehicles, road sweeping vehicles, to more general use vehicles. Specialist body building services, as well as options for alternatively fuelled vehicles (electric, hydrogen or hybrid etc.) will also be included. Scottish local authorities and various other contracting authorities may, if made available, request lease quotation, vehicle buy back options, disposal of aged fleet options and second hand vehicle purchase options for heavy and municipal vehicles.
