The programme aims to fully exploit innovation in digital and other technologies to provide a fully blended, interactive, and innovative programme that will meet the requirements of the new standards (2019) that the Nursing and Midwifery Council (NMC) has set for pre-registration midwifery programmes.

This is an exciting opportunity to support the creation of a significantly different offer in midwifery education that will support the growth of a qualitatively different expert and professional workforce suited to the demands of 21st Century care and service.
