Please note that the stated contractual value includes the full maximum value of this service including all potential options to extend and proposed social care funding. This is calculated with reference to the committed public health funding over 5 years of £24,470,000 alongside the proposed social care funding of up to £2,000,000. In addition, this service incorporates an optional extension period of 2 years, thereby resulting in a maximum 7 year

contractual term with a value of £40,753,800 inclusive of the proposed social care spend. Furthermore, the scope of this procurement will factor an additional 10% flex to enable additional provision due to the inherent developmental nature of this service, this amounts to £4,076,380. The cumulative maximum value of this service is £44,840,180.
