The DMAcad is responsible for the provision of medical training for the Defence Medical Service (DMS) community, including Environmental Health Practitioners. Whilst much of this training is delivered using internal assets, this also requires external involvement and validation from an Academic Partner.

Currently Military Environmental Health students complete a 4-year course to qualify as an Environmental Health Practitioner (known as Class One status in the Army), which includes award of a BSc (Hons) Degree in Environmental and Occupational Health. The academic award is validated by a Contractor, which delivers seven of the nineteen modules. The remaining course content is developed and delivered by the Department of Environmental and Occupational Health (DEOH) at DMAcad.
