Within Sefton Integrated Substance Misuse Treatment Service, the first-line detoxification offer is community detoxification within the adult treatment service. Where increased risk is indicated, residential in-patient detoxification may be the safest and most effective treatment plan. Medical input and supervision can be provided by a community GP overseeing the detoxification plan.

However, medically managed inpatient detoxification is an important treatment option for service users who:

Have not benefited from previous formal community-based and/or medically supervised inpatient detoxification

- 

Need 24 hour specialist substance misuse medical and/or nursing care because of

significant co-morbid physical or mental health problems

- 

Require complex polydrug detoxification, for example concurrent detoxification from alcohol or benzodiazepines

Are experiencing significant vulnerabilities or social problems that will limit the benefit of community-based detoxification

- 

Have complex needs that require admission for medical stabilisation.
