North of England Commissioning Support (NECS) is a commissioning support service working for and on behalf of NHS Cheshire and Merseyside Integrated Care Board (NHS CM ICB) (the Contracting Authority), who are undertaking a procurement to commission APMS contracts for Old Hall Surgery, Westminster Surgery and Special Allocation Service, Willaston Surgery Alternative Provider Medical Service and St Werburgh Homeless Practice and Special Allocation Service.

The contract term is for an initial period of 5 years commencing on 01 October 2024, with an option to extend for a further 4 years at the discretion of the Contracting Authority and subject to satisfactory contractual and financial performance.

The closing date for submission of tenders is by 12 noon on 04 March 2024

#### **Additional information**

Firstly, the "Transfer of Undertakings (Protection of Employment) Regulations 2006" as amended by the "Collective Redundancies and Transfer of Undertaking (Protection of Employment) (Amendment) Regulation 2014" (TUPE) [may/does not] apply to this contract. However, Bidders are advised to obtain their own legal advice and carry out due diligence including the New Fair Deal non-statutory policy setting out how pensions issues are to be dealt with when staff are compulsorily transferred from the public sector to independent providers delivering public services.

Secondly, previous publication concerning this procedure published on 04 September 2023 under title: Old Hall Surgery APMS, Westminster Surgery and Special Allocation Service APMS, Willaston Surgery APMS and St Werburgh's Homeless Practice and Special Allocation Service APMS.
