Central and North West London NHS Foundation Trust (CNWL) is a combined trust that provides services throughout a person's life, covering community, sexual health, mental health, offender care and addictions services in London, Milton Keynes and beyond. This includes providing mental health care to the North West London population of Brent, Harrow, Hillingdon, Kensington & Chelsea and Westminster

This service will be used by the Contracting Authority to provide Community Step Down Services for eligible patients across the geographical locations of all five North West London boroughs: Brent, Harrow, Hillingdon, Kensington & Chelsea and Westminster.

The Trust is seeking to commission an external agency to provide a supported accommodation service for individuals to 'step down' from acute mental health inpatient units. The provider will be located across all five North West London boroughs to ensure good accessibility, with adequate 24/7 on-site support.
