Doctors can self refer and are assessed by a doctor adviser, qualified in physicians health, before being referred for face to face counselling.

Due to the higher levels of stress and anxiety during the COVID-19 pandemic, further exacerbated during the second wave, the Health for Health Professionals Service has been extended to be provided as a matter of urgency to all of the NHS workforce and also the Social Care sector for 2021 to 2022.

This will include support for a changing workforce with retired doctors and final year medical students forming part of the future service delivery and the Social Care sector.
