The audit trail in respect of the evaluation and moderation does not capture sufficient detail for the reasons for the scores awarded.

The implications of the devolution of power (as set out in the English Devolution White Paper published on 16 December 2024) for each of the Councils involved in the Procurement are currently unclear and it is necessary to consider the delivery of these services in light of this development.

It would be pertinent for the Councils to take the opportunity to consider the tender and contract requirements to ensure that the service meets the Councils' needs whilst also being affordable and obtaining value for money.
