- ii. A GMP software utility that will shall additionally extract appointment data to facilitate the reporting of appointment activity.
- iii. A 'Module Management Utility'
- iv. A 'Module Authoring Tool' that will enable the Authority to develop modules to be deployed to the GMP software utility
- v. Data submission management
- vi. The provision of an endpoint (the DQS Endpoint) to receive and process aggregate data submissions from the GMP software utility
