Cardiff Council (the 'Contracting Authority'), on behalf of Cardiff Capital Region invites tenders from suitably qualified and experienced contractors to provide a reliable, effective service comprising the installation, operation and maintenance of Electric Vehicle (EV) chargepoints, with an aim to encourage taxi drivers to purchase ultra-low emission vehicles across ten local authorities in South East Wales namely Cardiff Capital Region (CCR). The region includes:
