- To improve data linkage results and reduce processing effort by replacing the NRS on-premise “Bigmatch” data linkage solution with an Azure based “Splink” solution, with security and data governance inbuilt;
- To introduce new functionality and simplify business processes;
- To have a fully tested and fully supported solution that is DEA, DPA and Cyber Essentials+ compliant; and
- To migrate to the new solution as soon as possible.
