The funding for the expansion of the services will come initially from Welsh Government Phase 2 transitional funding. This will last until 30th March 2021 where it will be replaced by Housing Support Grant funding. Welsh Government has made funding available for this purpose for 2020/21 and it is anticipated that the services will be absorbed into the Housing Support Grant thereafter.
