The successful Supplier will be required to provide cleaning services for North Learnington School (the Client) which, as present, is the sole school in Elm Tree Multi Academy Trust.

The contract will commence on 1 August 2023 for a period of three years, with the potential for an extension of up to a further three years on a 1 + 1 + 1 basis.

This contract will be fixed price in nature with the successful Supplier also guaranteeing the number of input hours to the contract as well as the quality of cleaning provision.
