The Flying Start childcare is being commissioned on a fixed price model, in line with Flying Start programmes across Wales. The rate has been set at GBP13.80 for Lots 1-10 and GBP14.80 for Lots 11 – 25.

A discretionary sustainability grant will be made available for providers against a set list of eligibility criteria.
