We want to expand the availability of Community level 2 interventions to people living in Norfolk to ensure that smokers can access the right interventions at the right time. The service will comprise the following key elements: - Community Stop Smoking service delivered by level 2 trained advisors. A focus on engaging communities where smoking prevalence is highest. - Service will be easily accessible via a triage/referral for on the Norfolk Ready to Change platform. - For people who are self-motivated to stop smoking, may live in areas of deprivation, may be in low-income employment but do not have other complex needs - Working with the specialist stop smoking service, primary care, and Integrated Care Systems to develop pathways that ensure smokers are accessing the most appropriate service based on need. - Providing a range of hybrid and innovative support options to individuals within the community to be empowered to stop smoking.
