- Understanding of Greening Government Sustainable Procurement requirements and how to implement these.

- Creation of methodology to evaluate and monitor social value contribution of new and existing suppliers

- Creation of a toolkit including examples of social value questions linked to a variety of different project requirements etc. Including provision of templates for social value questions with associated guidance which supports colleagues with rationale.
- Production of a Suppliers Code of Conduct incorporating but not limited to Sustainability, EDI, modern slavery, anti bribery etc
- Drafting of a Modern Slavery Statement for the Heritage Fund
- Provide recommendations for improvement
