Quality & Innovation; 20%; The lifestyle navigators, as part of the Active Dorset delivery model, are qualified in various healthcare roles. The service provided is innovative and offers flexibility to accommodate any changes in requirements, as determined through data analysis.

Value, 20% - Overall benefits provided such as enhancing accessibility to services and mitigating health disparities. The emphasis on personalised care and access to prevention-focused interventions ensures value is delivered to meet individual needs effectively.
