This project is a combination of refurbishment and replacement of existing office accommodation, workshop, welfare and other facilities on the site ensuring it 'future proofs' depot operations. Energy efficiency and functionality are key principles and the Project will use a wide range of energy efficient, generation and storage/distribution solutions to support a move to an electric powered operational fleet whilst reducing the site carbon footprint.

This procurement opportunity relates specifically to Electric Vehicle Charging Points and North Tyneside Council will act as Principal Contractor for the project, therefore tenderers should note that they will be working in the capacity of Sub-Contractor. Tenderers must be aware that this is an operational site and as such works must be undertaken taking into consideration the ongoing operations of the site and innovative delivery solutions to ensure disruption to the service is kept to a minimum.
