The usual timescales for competitions under the Public Contracts Regulations 2015 could not be complied with, because immediate access to lateral flow testing kits was required to support Sellafield Limited's commitment to the safety of its employees, including ensuring that the minimum safe manning criteria is maintained on site for essential high hazard and risk reduction activities.
