The original contract was let to the 31/03/2025 this modification will extend the contract until the 31/12/2025.

This contract is being modified in accordance with Regulation 72.1.b. of the Public Contracts Regulations 2015. The modification will extend the contract for the The provision of strategic project management and leadership within the Together an Active Future programme as part of Sports England local delivery pilot for 9 months.

This is being extend on both grounds;

The original contract length was set due to funding being provided by Sports England for 2 years until the 31/03/2025, additional funding has now been provided to extend this scheme until the 31/12/2025 which was not foreseen by the authority.

Due to economic and technical reasons a change of contractor would cause significant inconvenience or substantial duplication of costs for the contracting authority.
