Tenderers are advised that during 2019/20 PA Housing advertised 169 vacancies which attracted over 2,600 applications and scheduled over 550 interviews. On average we had 15 applications per role (this figure is a bit skewed by internal vacancies that had no applications). We had over 160 new starters. This does not include those that were employed via an agency. The services required by this contract, can include but are not restricted to:

- Post adverts to sites such as Facebook, Linked-in, Twitter, Instagram and In-deed.
- Deliver a streamlined, efficient and counter intuitive experience for PA staff and applicants.
- Manage the application process

- Be forward thinking in utilising technology to deliver greater efficiencies in response rates, cost and deliver a blended approach to the recruitment process.
