The containers will be used on hard standing in a waste disposal environment on the County's Household Waste Recycling Centres.

The HWRCs require robust containers to be used for the storage and transport of waste. The containers are essential to the safe and efficient operation of the HWRCs.

The Council is seeking to appoint a single Supplier.

The number of containers to be procured per year is limited to budgetary constraints.
