Current challenges are that public transport within Buxton and Leek is heavily orientated

towards facilitating travel out of the Buxton and Leek towns towards Stockport and

Manchester and do not facilitate frequent and flexible travel to our teaching sites. The towns

are in remote locations with many of our staff and students attending Buxton and Leek living

in remote residential areas thus requiring transport routes that reach out to a wide geographical spread.

The existing value of the public transport for our Buxton Campus is £450,000 per year.
