The underpinning ethos is to maintain and improve a person's ability to remain independent within their own property and where possible to provide a home for life. Extra care in Hartlepool includes access to on site care and support services 24/7, 365 days per year to help to maintain independence.

The provider will be expected to show a commitment to partnership working, quality assurance and continuous improvement. Performance will be monitored through self-assessment and the departments monitoring process for domiciliary care providers.
