Birmingham City Council (BCC) is working with West Midlands Children's Services (a collaborative of 14 Local Authorities (LA's) and Children's Trusts (Trusts)) to undertake Soft Market testing exercise for a web-based IT solution that provides a single portal for use by all 14 LA's and Trusts that enables brokerage of services and placements searches across a number of frameworks.

The West Midlands Local Authorities & Trusts include Birmingham Children's Trust, Coventry City Council, Dudley Metropolitan Borough Council, Herefordshire Council, Sandwell Children's Trust, Shropshire County Council, Solihull Metropolitan Borough Council, Staffordshire County Council, Stoke-On-Trent City Council, Borough of Telford & Wrekin , Walsall Council, Warwickshire County Council, Wolverhampton City Council and Worcestershire Children First.

There are approx. 200 staff from commissioning and placements teams across the 14 LAs and Trusts that are registered users of the current system and around 800 providers. This is subject to change as new frameworks are added.

The existing system is due to expire in 2022 and we are interested to learn about innovative ideas and potential future solutions for its replacement.
