Lot 5, the deployment of integrated smart energy systems across a portfolio of multiple assets. The integrated smart energy system may include a mixture of technology types, including those that are featured in lots 1-4. In addition other technologies may also be suggested by Suppliers at the mini competition stage, and subject to the Contracting Authority agreement be included. These 'other' technologies might for example include but are not limited to ultra-rapid electric vehicle charging hubs/ forecourts, standalone (grid-connected) battery storage, wind turbines, and hydro-electric plants, platform (software/ hardware) for aggregating generation/ demand and interacting with a potential future local energy market.

The framework will provide sufficient flexibility to accommodate the range in needs and requirements of the Contracting Authorities in terms of technical solutions, portfolio scale, investment options and delivery models.
