SOS also provides English for Speakers of Other Languages (ESOL) and Unaccompanied Asylum-Seeking Children (UASCs). By offering schools in Surrey the option to set up lessons quickly the service has helped to reduce Permanent Exclusions as well as give children the opportunity to achieve academically which they may not have been able to otherwise do.

The service supports children with a range of medical needs, such as anxiety; those at risk of permanent exclusion; school refusers; Looked After Children and those with additional needs (SEND).
