- aligned with and supports the Curriculum for Wales and one or more of Adnodd's focus areas; literacy, equity and anti-racism, and well-being.
- developed and available by 1 March 2027

Resources must primarily be in digital format; however, printed materials may also be included in proposals provided there is clear justification, supported by compelling evidence of need.
