The Chemical, Biological, Radiological and Nuclear Delivery Team (CBRN DT), part of the Defence Equipment and Support (DE&S) Organisation within the UK Ministry of Defence (MOD), seek to place a new single source Contract with Bruhn Newtech Ltd (BNT Ltd) for the support of Biological, Radiological and Chemical (BRaCIS) Warning and Reporting (W&R) software for a period of 5 years to FY 2031 with 2 x options years to provide a continuing requirement to support the In-Service CBRN W&R software including training for UK Defence.
