This includes Frimley Health NHS Foundation Trust (Frimley Park Hospital & Wexham Park Hospital) and affiliated community hospitals; Royal Berkshire NHS Foundation Trust and affiliated community hospitals; NHS Frimley ICB including East Berkshire area of Berkshire Healthcare NHS Foundation Trust and affiliated community hospitals, as well as North East Hampshire & Farnham and Surrey Heath areas; Berkshire West area of Berkshire Healthcare NHS

Foundation Trust – which falls under Buckinghamshire Oxfordshire, Berkshire West (BOB) ICB and affiliated community hospitals.

This includes enteral feeds and oral nutritional supplements (ONS) for hospitals.

Enteral feeds and ONS for administration via enteral tube only for community/ primary care sector to be provided either on or off FP10, depending on the area. This based upon the current service models. The current off FP10 model will remain in the community around Frimley Park Hospital (Horth East Hampshire & Farnham and Surrey Heath Places). Other areas will remain on FP10 (community usage in East Berkshire and West Berkshire)
