(a) legitimate, viable governance structures able to make and enforce rules locally and

(b) existing and emerging conflicts brought to conclusion and risks of future conflicts mitigated.

The Stability Fund II is an ambitious and risk-taking programme, with a design predicated

on flexibility and responsiveness. It operates according to a series of principles, which serve as sub-objectives and which are important for the Stability Fund's operations
