Basis of Contract

The Client wishes to participate in a tender process with the intention of appointing a quality catering company to deliver full catering services. The contract will commence from September 2022 and will be for an initial period of 3 years plus an option to extend up to a maximum of 5 years.

In order to deliver best value, the contract will be awarded on a 'Cost-Plus' with fixed guaranteed lines on food and labour costs.

The revenue is estimated to be £650,000 (over 3 years).

Objectives

The appointed Supplier will have significant experience of delivering quality catering services within secondary schools and should have suitable experience and expertise of successfully increasing pupil meal uptake and lunchtime sales growth. With all catering paid the London Living Wage the Supplier will ideally have a strong operational base in London with proven ability to manage an efficient catering service that delivers sustainable 'best value' to the school.
