The JCVI has made a recommendation that Shingrix exclusively be used for the national shingles vaccination programme due to the superiority of the vaccine and DHSC is obliged by law to adopt that recommendation, and the Supplier has global exclusive legal rights to manufacture and distribute Shingrix.
