The Royal National ENT & Eastman Dental Hospitals has 85,000 outpatient attendances annually, of which 35% are children and adolescents. Patients are referred from a wide-ranging geographical area, with this broad referral base placing the Eastman in a prime

position for the delivery of education and training for all groups of professionals in dentistry. This includes consultants, specialists, researchers and clinical educators as well as those aspiring to become dental care professionals (DCPs) which include dental nurses, hygienists and therapists.
