The Council requires the Contractor to report on the following elements as a minimum (quarterly unless otherwise stated):

- Timescales for delivery of new bins to be within 6 weeks of order
- Timescales for bin refurbishment to be within 4 weeks from collection to return
- Invoices to be received within 30-days of any new/refurbed bins being delivered
- Social Value will be monitored via The Social Value Portal:

The Tenderer's Social Value proposal is a contractual commitment for the successful Tenderer to deliver on behalf of the Council. Performance/delivery progress against the commitments made by the successful Tenderer will be monitored by the Council and the Social Value Portal. This will require the successful Tenderer to upload periodic progress information via the Portal to produce periodic reports. Measuring and reporting on Social Value is a developing field, and Oldham Council recognises that flexibility and a collaborative approach are required. A key requirement is the willingness of the successful Contractor to work openly and transparently with the Council whilst bearing in mind that the overall value of Social Value commitments made must be delivered.
