The ICB Cancer Committee, duly constituted in line with its terms of reference, is authorised to determine the use of their delegated budget for Cancer services, from this

budget the funding associated with the Provider is £883,361 for 24-25.

The WS Alliance have agreed to transfer the GP Fed Streaming contracting work over to WSFT for them to sub-contract directly. This will result in payment for the core service of £517,545 being transferred recurrently into WSFT contract for GP streaming from 2024/25.
