The Council has a requirement for a Multi-lot Framework Agreement for the provision of Furniture Removals and Storage.

The Council has yet to finalise the required contract term and the estimated value is based on a period of three years with options to extend for two further periods of up to 12 months each.

The Contractor must be able to provide the service within the boundaries of the City of Edinburgh. Any properties that the Council owns outwith the City must be included.
