Additional funding from NHS SEL ICB to be added to the Contract Value which brings the revised annual total Contract Value from £743,719,000 to £878,054,797.

The lifetime value is now £4,390,273,985. This modification is effective from 10th January 2025.

The contract term is three years, plus an additional 2 year term at the discretion of the Authority, commencing on 1st April 2024.
