We require an MRI compatible neonatal incubator for use in pre-clinical neonatal neuroprotection studies at the Large Animal Research and Imaging Facility (LARIF), University of Edinburgh. These studies are of a highly specialised nature; the subject requires 72h intensive care support and within this period, 2 MRI scans.
