The contract term being tendered is for three years, 1st September 2025 – 31st August 2028. There is an option for a further extension period for up to two additional years to 31st August 2030.

The contract offers an excellent opportunity to review and propose enhancements to the current catering services at the School, where the uptake is high. This includes but is not limited to; breakfast, morning break and lunchtime, over the academic year.

The catering offer is Kosher and the school is keen to engage with a contractor that can provide assurance that a Kosher offer would be delivered both compliantly, and to the high standards that the school expects. Therefore, the school welcomes expressions of interest from catering companies either with experience in delivering Kosher catering, or from companies who have knowledge and experience of Kosher catering within its staff base/ organisation, that could be deployed to meet the school's catering delivery requirements.

The school is keen to secure a high quality catering service including fresh locally sourced ingredients prepared on site, with a menu design that is flexible to suit the requirements of the school's specific students. The school is proud of its 'family ethos' and expects both a tightly managed service and a management style delivered by the successful contractor that supports, encourages and develops the catering staff.
