## II.2.4) Description of the procurement

Improved digital connectivity is a mayoral priority and LCR has some key digital assets that provide a significant

competitive advantage to the attractiveness of the region. The "super-computer" is located at SciTech

Daresbury, in Halton and the superfast GTT trans-atlantic cable reaches the UK mainland at Southport in

Sefton. The LCRCA has ambition that these locations are interconnected and at the same time a digital
