The London Borough of Bexley is intending to use a Dynamic Purchasing System (DPS) for the procurement of Travel and Transport Services for Children's and Adult Social Care & Health Services.

The Council are looking to open up our access to the market through the use of a DPS, where new suppliers can join an approved list at any time throughout the lifetime of the contract. The contract runs for 3 years 4 months (1st April 2025 - 31st July 2028). There will be some requirements where users of the service have either been placed or attend services outside of the borough, these requirements will also be sourced through the DPS. The Council currently spends approximately £9m per annum on travel and transport provision for Children's Services and Adult Social Care & Health Services. The majority of the transport opportunities sourced through the DPSwill be required mainly for the following reasons:

i For Children/Young Persons, transport may be provided to and from school/college

ii For Adult's, transport may be provided in order for them to access community support services, respite centres and other provision

iii Other transport requirements for Children's Services and Adult Social Care & Health Service.
