The Healthcare Quality Improvement Partnership (HQIP) is seeking to commission an organisation that will support the delivery of the Cardiovascular Disease Prevention Audit (CVDPREVENT): Workstream 3.

The programme will initially be delivered for NHS-funded care in England but may later extend to include Wales, Scotland, Northern Ireland, Jersey, Isle of Man, Guernsey and other Devolved Nations/ Crown Dependencies.

The total contract value is £871,000 excluding VAT for the duration of three years with potential to extend the contract for up to two additional years at a value of up to £290,333.33 per year.
