#### **II.1.4) Short description**

Bristol City Council (BCC) currently invests 1.9m in the provision of Targeted Youth Services (TYS). These support young people from the age of 11 to 19 years (or up to 25 for care leavers). BCC also invests 100k in supporting the youth sector via its Sector Support Fund.

TYS supports young people through a combination of 1-2-1, targeted groupwork, open access and detached/outreach work. This support is primarily aimed at supporting young people's emotional health and well-being (including drugs & alcohol support), helping to track young people's current educational status and providing Education, Employment and Training support.

The current TYS contracts (North, East Central & South) are due to expire in May 2023
