NHS England – Midlands is looking to gauge the potential market interest for providing Integrated Healthcare services at Lincolnshire Cluster - HMP YOI Lincoln, HMP North Sea Camp, HMP Morton Hall, Swindery Short-Term Holding Facility. Nottinghamshire Cluster - HMP YOI Nottingham, HMP Ranby, HMP Lowdham Grange and HMP Whatton and Hereford and Worcestershire Cluster - HMP Hewell and HMP Long Lartin. The lotting strategy will be confirmed following the market engagement event.

The proposed contract is for an initial term of 7 years with an extension of up to 2 years (i.e.  $7+2 = 9$ ) commencing on 1st April 2023. However, please note the contract term will be subject to final approval by the commissioner.

The aim of the market engagement exercise is to inform potential providers of the opportunity and to assist the commissioner in deciding on the most appropriate strategy for the future procurement.
