The eDEN system is used by approved money advisers, creditors, payments distributors and AiB staff. AiB have a requirement for further development of their IT systems.

This modification is to extend the duration of the contract for 6 months, until 30 September 2021. The services provided under this contract will not change.

### **VII.2.2) Reasons for modification**



Need for modification brought about by circumstances which a diligent contracting authority/entity could not foresee.

Description of the circumstances which rendered the modification necessary and explanation of the unforeseen nature of these circumstances:

The on-set of the ongoing COVID-19 pandemic has created unprecedented uncertainty in relation to the work undertaken by AiB. Throughout 2020 various AiB IT system changes had to be made at short notice to accommodate emergency legislation amendments in relation to COVID-19. This has impacted the capacity of AiB to fully establish the IT development requirements going forward and retender the contract at this time. This modification will ensure continuity of essential system development and allow AiB to complete the procurement process and transition to a new contract.
