This rapid literature review should seek to:

- 1) Synthesise what is known about effective health and care systems that provide high quality care, identifying the key characteristics of these systems, and the conditions that support them, focusing on those systems where assessment or evaluation has determined them to be well-performing, and their effectiveness has been shown to benefit the needs of the local population.
- 2) Synthesise evidence about the factors that enable systems to improve their performance as well as barriers to improvement.
- 3) Synthesise transferable insight from across different definitions of systems in health and social care to reflect the ongoing development of these entities and prior learning from different system configurations (e.g. New Care Models and Vanguard).
- 4) Reflect on how existing research can be used to inform CQC's assessment of Integrated Care Systems (ICS) and Local Authorities
