A framework contract worth up to £485m for decommissioning and asbestos removal will be the focus of a Magnox webinar for suppliers. The webinar will be held on 21st April 2021 and is part of the company's on-going engagement with the supply chain as it drives forward its decommissioning mission.

Companies are encouraged to register early for the event about the four-year multi-supplier framework contract, which will involve asbestos removal, demolition and deplanting across Magnox's 12 sites around the UK. Some of the work will be in conventional areas and some will be delivered in radiological contaminated areas.

Linda Sapsford, Head of Procurement and Supply Chain, said: "Magnox is keen to share

news of this framework contract with demolition and asbestos contractors, both large and small, and to seek their input to help the development of our procurement strategy.
